(a) particulars of the public body, its functions and duties;

Punjab Health Initiative Management Company (PHIMC) is licensed and registered under section 42 of the Companies Act 2017 in the province of Punjab, with Registrar Joint Stock Companies, Lahore. The main task of the PHIMC is to execute social health protection initiatives, demand side financing schemes including pro-poor health insurance schemes and collaboration with private sector to provide universal health Insurance.

The Government of Punjab is committed to the principles of Universal Health Coverage and is approaching this goal in a phased manner. To improve access of population, to good quality medical services, a phased social health protection approach has been adopted. In the initial phase, free health insurance was provided to the population living below the poverty line, special persons and transgender community. The objective was to improve access to health services by the vulnerable groups in the Punjab through a reduction of financial barriers and strengthening of the quality of health service provision and ensuring future expansion of the scheme through a rigorous monitoring mechanism.

Universal Health Insurance has been launched in all districts of Punjab, where all the permanent residents of Punjab as per NADRA record are eligible to receive health coverage under Sehat Sahulat Program using their CNIC as health card.

The Company is also working on different arrangements within stipulated legislative and policy frameworks to further strengthen the health service delivery in the Punjab. More than 850 public & private hospitals are providing free health services to the permanent residents of Punjab through "Qaumi Sehat Card".

Core functions of the company:

- To advocate, undertake, and engage in such activities that contribute to the provision of sustainable universal health coverage for the population of Punjab
- To promote and implement Demand Side Financing for health, including results-based financing, specific voucher schemes, health protection/ insurance schemes for the poor, and an Integrated Health Insurance Scheme for the population of Punjab
- To improve access to health care services for the population of Punjab of an acceptable quality and reasonable cost through special initiatives
- To protect the population of Punjab, especially the poor, from impoverishment due to health care expenditures
- To promote, provide, and establish healthcare facilities and establishments for preventive, diagnostic, and curative purposes under public-private partnership (PPP) OR OTHERWISE on behalf of the Government of Punjab.
- To ensure equitable distribution of health benefits among the population of Punjab, especially the poor through initiatives managed by the company

- To monitor the standards of health care delivery services within the initiatives /health insurance scheme and ensure adherence to provincial quality standards laid down under the Punjab Health Care Commission Act
- To improve access to and utilization of private sector health institutions in the provision of health care services under the company's initiatives
- To ensure access to required health care to the beneficiaries under the company's initiatives within the province of Punjab through the involvement of public and private health providers
- To promote the health insurance scheme through educating and creating awareness among the population of Punjab, to promote risk pooling, and decrease catastrophic health care expenditures

Function and Duties

1. **Chief Executive Officer:** Responsible for overall leadership and management of the public body, implementing strategic objectives, ensuring effective operations, and representing the organization.
2. **Chief Operating Officer:** Oversees day-to-day operations, coordinates activities across departments, and ensures efficient utilization of resources to achieve organizational goals.
